#### **1. BACKGROUND**

1.1. Tourism KZN is responsible for promoting the province of KwaZulu-Natal to domestic and international travelers. A key enabler to promote the destination is the use of technology.

#### **2. SCOPE OF SERVICES**

2.1. Tourism KZN is looking to renew its current Realsign solution for a period of 12 months.

2.2. The Realsign solution is currently in operation in the environment.

2.3. The total transaction count that will be included in the system is 4300 transactions.

2.4. The total digital certificates count that must be supplied is 6200 certificates.

(b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
