- **STAGE 1 – COMPLIANCE WITH MANDATORY REQUIREMENTS**

All proposals must be completed and accompanied by:

- The bidder must be registered as a vendor on the National Treasury Central Supply Database (CSD)
- The bidder must be in good standing with SARS, the information will be verified through Central Supply Database (CSD) and SARS e-filing

pin in compliance with Instruction Note 9 of 2017/2018 prior to the award of the quotation.

- SBD 1- A resolution letter MUST be attached as per requirements of SBD 1.
- SBD 4- Declaration of Interest
- Bidder must have a minimum of five (5) year’s previous experience in mainstream newsroom (Must provide CV or Press card as evidence of experience)
- Bidder must have a minimum of three (3) positive reference letters from previous clients.

PRICE AND SPECIFIC GOALS

- Proposals will be evaluated using the 80/20 preference point system. 80 for price and 20 for preferential/specific goals.
- Price and Preferential/Specific goals evaluation will be carried out on bidders who qualified in stage 1 of the evaluation (Mandatory requirements)
