C. SPECIFICATION/ TERMS OF REFERENCE

REQUEST FOR QUOTATION FOR FORMULATING A SERVICE LEVEL AGREEMENT BETWEEN TOURISM KWAZULU-NATAL AND THE PROFESSIONAL TEAM/ PRINCIPAL AGENT FOR THE KWAXOLO CAVES PROJECT

1. BACKGROUND

- 1.1** The attorneys need to formulate a Service Level Agreement between Tourism KZN and the Professional Team/ Principal Agent that will be appointed to manage a suitable Contractor for the construction of tourism product facilities at KwaXolo Caves.

2. SCOPE OF WORK

- 2.1** To formulate a Service Level Agreement (SLA) between Tourism KZN and the successful professional Team/ Principal agent to manage the main Contractor to execute the proposed development at KwaXolo Caves. In addition, the appointed Principal Agent in consultation with TKZN, will have to source the contractor and labour from the relevant local municipality through the list of qualified and capable service providers from the local municipality.

- 2.2** The SLA must also ensure that the Professional Team/ Principal Agent do the following:

- To prepare tender documentation for the procurement of a contractor, management of sub-constructing in consultation with TKZN to ensure that the contractors and labour are sourced from the local municipality at which the project exists.
- To ensure that the Contractor complies with EPWP requirements for labour and training as per the requirements.
- The Professional Team is to follow the recommendations and the product development plans, which includes design development that are already in place, this done in consultation with the Project Steering Committee throughout the duration of the project.
- Prepare preliminary costs estimates for the implementation within the proposed budget. The development of the budget is to be done in consultation with the Project Steering Committee to ensure that the allocation of budget resources is implemented according to the site requirements.
- Provide construction supervision of the implementation of the project including close out.

- 2.3** The SLA must also outline the detailed responsibilities of the Project team which must include the following:

- Review, monitor and evaluate the Project Implementation Plan with particular reference to the allocation of the budget, the time schedules and management of risks.
- Management of the appointed Contractors and liaison between the team and Tourism KZN and the Project Steering Committee; The appointed Principal Agent should ensure that the contractor possess the required CIDB grading certificate relevant for the project.
- Monitoring and managing the project implementation process so that the objectives as set out in the Project Implementation Plan, and any subsequent amendment thereto, are achieved.
- Providing regular monthly reports to the relevant Tourism KZN Project Manager on progress, projected and actual expenditure, throughout the duration of the project.

- Deliver milestone presentations to Tourism KZN and the Project Steering Committee as and when required by Tourism KZN.
- Managing the professional fees on behalf of the professional team and ensuring that it is not exceeded.
- Preparing recommendations for the works procurement approach and form of contract.
- The management and supervision of the contractor and sub-contractors on behalf of TKZN.
- Ensuring that all documentation submitted complies with the requirements of Tourism KZN, the Project Steering Committee and the stipulation of the EPWP and Social Responsibility Programme of the Department of Tourism.
- The Project Manager will certify every certificate issued for payment and must ensure that they comply with the PFMA Act (1999) to avoid fruitless or wasteful expenditure on the project.
- The Project Manager will make recommendations on any matters relating to potential under- or over- expenditure of the project budget or the agreed programme for implementation.
- The Project Manager must ensure that the project conforms to the required construction and service standard as required by South African legislation and that it complies with the requirements of Tourism KZN and the Project Steering Committee.
- The project manager will ensure that practical and final completions are done to the satisfaction of Tourism KZN and the Project Steering Committee

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
