TERMS OF REFERENCE

1. PURPOSE OF THE TERMS OF REFERENCE

1.1 Tourism KwaZulu-Natal (TKZN) seeks proposals from interested and suitably qualified Events Companies to provide décor and coordinate TKZN's summer season Activation event happening on 16 or 17 November 2023 / 23 or 24 November 2023.

1.2 In coordinating and managing the summer season Activation event, the successful service provider will:

- Provide infrastructure for outdoor event.
- Coordinate and manage the event.
- Provide decoration for the event.
- Provide catering for the event.
- Provide suitable Program Director for the event.

2. ABOUT TOURISM KWAZULU-NATAL

The KwaZulu-Natal Tourism Authority, trading as Tourism KZN (TKZN), which operates under the name Tourism KwaZulu-Natal, is responsible for the development, promotion, and marketing of tourism into and within the province. The Authority's statement of intent and direction is drawn from the mandate vested in the organization by the KwaZulu-Natal Tourism Act, 1996 (as amended, including No. 2 of 2002).

The vision of Tourism KwaZulu-Natal is to position the province of KwaZulu-Natal as Africa's leading tourism destination, nationally and internationally. To achieve this mandate, TKZN needs to continuously increase destination's profile and ensure brand awareness in all the province's key source markets, through stakeholder relations.

2.1. The Authority's primary objectives are to develop marketing programs/tools to accomplish the following:

- Increase arrivals into the province.
- Increase tourist spend.
- Increase length of stay of visitors.
- Increase geographic spread of visitors.
- Improving seasonality patterns
- Contribute towards transformation of the KZN Tourism industry.

2.2. In order to achieve these objectives, Tourism KwaZulu-Natal seeks to create tourism awareness through TKZN's Summer Season Activation event. As such, Tourism KZN seeks to appoint a suitable service provider on a non-exclusive basis to execute this event.

- Provide a stretch marquee that will be erected at identified venue big enough for the 150 pax.
- Provide Program Director (with experience for program directing and has done Tourism business events)
- Provide décor furniture for main marquee for 150 pax.
- Provide lounge décor set up with a mix of couches and occasional with small tables
- Provide center pieces for each table ie simple flower arrangements for a day event.
- Provide catering for 150 pax, including refreshments and soft drinks
- Provide tea/coffees and finger foods for 30 pax
- Provide bottled water for 150 pax
- Provide cutlery and plates for catering.
- Provide additional marquee for catering purposes.
- Provide 2 artists for entertainment for event (1 local and 1 prominent).
- Provide a safety officer with a Health and Safety Compliance certificate/OHS certificate.
- Provide 4 fire extinguishers.
- Provide Stage (6m x3m): White
- Provide podium for event speakers.
- Provide 1 screen for the event for presentation or destination video
- Provide sound and equipment as per event and artist spec this includes mics for guest speakers.
- Provide green carpet for the floor equivalent to the marquee and stanchions ropes.
- Provide 6 VIP Toilets (3 gents, 3 ladies)
- Provide silent generator for power source.
- Provide registration desk and red/black stanchions at the entrance of the marquee.
- Provide sufficient staff for waitressing and ushering of guests.
- To manage and coordinate the event on the day.
- To manage the coordination of all event's activities, this includes the activities that will be organized by TKZN.

- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 - \frac{Pt - Pmin}{Pmin} \right) \text{ or } Ps = 90 \left(1 - \frac{Pt - Pmin}{Pmin} \right)$$

Where

- Ps = Points scored for price of tender under consideration
 Pt = Price of tender under consideration
 Pmin = Price of lowest acceptable tender under consideration

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 + \frac{Pt - Pmax}{Pmax} \right) \text{ or } Ps = 90 \left(1 + \frac{Pt - Pmax}{Pmax} \right)$$

Where

- Ps = Points scored for price of tender under consideration
- Pt = Price of tender under consideration
- Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
