TERMS OF REFERENCE

1. PURPOSE OF THE TERMS OF REFERENCE

1.1 Tourism KwaZulu-Natal (TKZN) seeks proposals from interested and suitably qualified tour operators to provide ground transportation for inbound agents who will be attending the KwaZulu-Natal Travel academy in Durban from the 14th of March 2024 to the 18th of March 2024.

1.2 Prospective service providers are requested to submit quotations for Conducting post tours and the transporting of guests and their luggage as per the below.

- The different vehicles used for the tours and transfers must be comfortable, air-conditioned, clean and roadworthy.
- The respective vehicles used for the tours must be 22-seaters with trailers for the guest's luggage.
- Arrive at pick up points on time and ensure that tours are conducted in a professional manner.
