#### **1. PURPOSE**

To request the Acting Chief Executive Officer for the approval to secure catering services for the (TKZN and Film) Joint APP session scheduled for the 13th of March 2024.

#### **2. BACKGROUND**

- 2.1 KwaZulu- Natal Film Commission (KZNFC) and KwaZulu-Natal Tourism Authority (KZNTA) are in the process of merging into one entity with the administrative processes of its strategic documents expected to conclude by 31 March 2024. On 19 January 2024, the joint board, and Management conducted the stakeholder strategy consultation session with the aim to review long-drafted strategy document for the new entity. The draft Bill to provide for the establishment of the KwaZulu-Natal Tourism and Audio-visual Agency (KZNTAVA) is currently being consulted province-wide through the KZN Provincial Legislature.

- Ps = Points scored for price of tender under consideration

**3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT**

**3.2.1. POINTS AWARDED FOR PRICE**

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left( 1 + \frac{Pt - Pmax}{Pmax} \right) \text{ or } Ps = 90 \left( 1 + \frac{Pt - Pmax}{Pmax} \right)$$

Where

- Ps = Points scored for price of tender under consideration
- Pt = Price of tender under consideration
- Pmax = Price of highest acceptable tender

**4. POINTS AWARDED FOR SPECIFIC GOALS**

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
  - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
  - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
