TERMS OF REFERENCE: PROVISION OF BOARD AND BOARD COMMITTEE SECRETARIAT SERVICES FOR TOURISM KWAZULU-NATAL

1. BACKGROUND

The KwaZulu-Natal Tourism Authority, trading as Tourism KwaZulu-Natal (TKZN), was established in terms of the KwaZulu-Natal Tourism Act, 1996, as amended by Act No. 2 of 2002. In terms of the aforementioned Act, TKZN is responsible directly and indirectly for the development, promotion and marketing of tourism into and within the province.

In terms of best practice, the Board should employ a Board/Company Secretary to assist in the provision of the governance, legal and compliance roles and responsibilities of the Board. The nature of work within the Board Secretariat, Risk and Compliance Services has increased and the service provider will give primarily focus on coordinating Board and Committee matters while the Board Secretary focuses on risk governance and compliance matters. The Board Secretariat Office within the CEO's Department therefore wishes to source a service provider for a period of 12 months. The entity wishes to strengthen the function of the Board Secretariat Office given the significant legislative compliance requirements of a public entity.

2. Purpose of the Terms of Reference

The purpose of the TOR is to call for proposals for the provision of Board Secretarial Support Services to TKZN for a period of 12 months.

3. SCOPE OF SERVICES AND OBJECTIVES OF THE CONTRACT

3.1 The overall objective of this contract is to procure the services of a consultant to fulfil the duties and responsibilities of a Board and Committee Secretary for at least 12 months.

3.2 Scope of work

The Board Secretariat Support reports operationally to the Board Secretary. This office reports directly to the CEO and is also accountable to the Board and reports to the Chairperson for the Board in this capacity.

The Board Secretariat Supports the Board by providing resources and information links among the Board, management and the shareholder, with particular emphasis on facilitating the flow of information.

The duties and responsibilities of the Board Secretariat Support is *inter alia* to:

- a) Attend Board and Committee meetings, and act as a Board Secretariat support at such meetings.
- b) Prepare minutes of the Board and Board Committee meetings and ensure that decisions taken by the Board and Committees are communicated to Management in a timely manner.
- c) Advise the Board Secretary, CEO and Board on all matters of procedure.
- d) Administer the Code of Conduct and Conflict of Interest Guidelines.
- e) Advice in respect of any matters where conflict, potential or real, may occur between the Board and the CEO/ Management.

- f) Keep the register of annual declarations for the Board and Senior Management Ensure, where applicable, that the standards and disclosures required by the applicable legislative framework are observed and where applicable are reflected on the Annual Report.
- g) Keep under close review all legislative, regulatory and corporate governance developments that might affect the entity's operations, and ensure the CEO is fully briefed on these and that it has regard to them when taking decisions.
- h) Assist the Board Secretary in acting as a point of contact and source of advice and guidance for directors as regards the entity and its activities in order to support the decision making process.
- i) Safe and secure filing and storage of all minutes and electronic recordings.
- j) Correct and up to date maintenance of a records register of all the resolutions taken at meetings.
- k) Ensure effective and efficient preparation of all Board and Committee meeting.

The Bidder's proposal should effectively and adequately, without ambiguity demonstrate how it is able to provide these services to the TKZN.

1.2 To be completed by the organ of state

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) “**tender**” means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

$$Ps = 80 \left(1 + \frac{Pt - P_{max}}{P_{max}}\right) \text{ or } Ps = 90 \left(1 + \frac{Pt - P_{max}}{P_{max}}\right)$$

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
