Tourism KZN will be participating at the Africa's Travel Indaba 2024. TKZN is therefore looking for a photographer that will assist to capture these moments so we can start to rebuild our tourism sector through powerful and impactful images that will capture the vibrancy of the tourism sector.

Africa's Travel Indaba comprises of various events and is attended by the global tourism community. Tourism KZN seeks the services of a professional photographer that has a strong media background to take pictures that can be used in various media platforms. The photographs will be used as part of the aggressive PR and Communication campaign to ensure that Destination KZN stands out from the clutter of the thousands of exhibitors and destinations that will also be attending Africa's Travel Indaba.

The photographer will be required to be always professional as they will be interfacing with key tourism stakeholders.

Due to the nature of this assignment, a quick turnaround time will be required from the photographer as the PR team will have tight deadlines to adhere to.
