REQUEST FOR QUOTATION, SAGE SOFTWARE RENEWAL, SUPPORT AND MAINTENANCE

SPECIFICATION

1.BACKGROUND

Tourism KZN is responsible for promoting the province of KwaZulu-Natal to domestic and international travellers. A key enabler to promote the destination is the use of technology.

Tourism KZN have an existing SAGE application system. The modules include:

- Sage 300 People Payroll & HR
- Sage 300 People Self Service
- 2 Payroll and HR users
- SAGE Performance Management (Implementation in progress)

The solution is currently licensed for 100 employees and an unlimited number of administrators. Furthermore, there is a merger of entities taking place between Tourism KZN and the KZN Film Commission. The successful service provider will be required to perform functions for Tourism KZN with regard to the merger.

2.SCOPE OF SERVICES

2.1 The successful provider will provide the full range of support for the TKZN SAGE application and backend SAGE application databases that are needed for the system to function.

2.2 The provider must have a helpdesk enabling all support requests to be logged and attended to within agreed service level agreements. Your response must adhere to the TKZN expected response and resolution times.

- High: Response = 30 minutes maximum, Resolution = 2 hours maximum
- Medium: Response = 2 hour maximum, Resolution = 8 hours maximum
- Low: Response = 4 hour maximum, Resolution = 48 hours maximum

2.3 The required services will be for 12 months, renewable based on the merger process outcomes and the supply chain management processes.

2.4 Tourism KZN requires a SAGE-certified provider to ensure that the SAGE application and databases are functional. This includes a variety of work and not limited to system updates and patches, resolving any issues preventing the system from being operational, SAGE application database problems etc.

- 2.5 The provider must have a minimum 3 year's experience in working with the above SAGE modules including the backend-approved database technology. The current database is on the Microsoft SQL Server platform.
- 2.6 The provider will ensure that the application and underlying software is kept up to date by a standardized patch management and upgrade/update path.
- 2.7 The service provider will implement the SAGE Performance Management module. This includes providing training sessions to train all staff on how to use the system.
- 2.8 The provider will provide application support on the SAGE application as per the requests by Tourism KZN. The provider will include a cost/rate per hour as part of your response.
- 2.9 The provider will be responsible for Mid-Year and Tax Year end EMP501 Submissions.
- 2.10 All changes to the SAGE application and associated software and databases must be approved via the TKZN Change control process.
- 2.11 All support work carried out on the SAGE application will include detailed reporting enabling Tourism KZN to process the associated invoices.
- 2.12 The provider must submit a detailed proposal including a response to each point indicated above. This will form part of the evaluation process.
- 2.13 The rate per hour must be aligned to industry standards. Tourism KZN may test the market should the need arise to confirm alignment. The rate per hour will be used for all work that is needed as per business requirements.
- 2.14 The service provider will be required to sign a penalty-based SLA to avoid any delay tactics to be practiced. Hence the service provider must be competent in the SAGE suite of products.

$$Ps = 80 \left(1 + \frac{Pt - Pmax}{Pmax} \right) \text{ or } Ps = 90 \left(1 + \frac{Pt - Pmax}{Pmax} \right)$$

Where

- Ps = Points scored for price of tender under consideration
- Pt = Price of tender under consideration
- Pmax = Price of highest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

Table 1: Specific goals for the tender and points claimed are indicated per the table below.
